Mr. Peterson,

I would like to inform you of the major NCAA violations that I am aware of in your baseball program, such as improper benefits to players, recruits, and coaches, failure to promote an atmosphere of compliance, payment to players, recruiting violations, allowing managers to serve as coaches, team practice time and start date violations, housing violations for players and coaches, threats from administrators to players and players parents, knowingly allow players to use illegal bats in competition, use of impermissible recruiter, complete disregard to physical and mental health issues and abuse, and **overall lack of institutional control**. These actions are not isolated or inadvertent as they happened over and over for years. I trust you will handle this internally and report these issues to the NCAA and not turn your head. I recommend you start your internal investigation immediately and place a show cause action on all former and current coaches of UALR.

If no public statement is made and action is not taken within 24 hours, all accusations will be sent to the NCAA and media.

Examples:

Coach Norwood physically assaulted player [REDACTED] at practice

Coach Gordon had recruits in during the dead period

Coach Marx knowingly allowed and scheduled team practice prior to NCAA rules allowed

Manager [REDACTED] was actively involved in team practices as a coach

Discounted housing rates for players and volunteer coaches

Mr. Hudson:

I am writing to confirm receipt of your most recent email and to invite you, again, to meet with me, Chris Peterson, or Mandy Abernethy so all facts of which you are aware may be properly addressed during our ongoing internal investigation.

In your email you demanded a public statement by UALR within 24 hours apologizing and admitting "to a lack of institutional control and failure to promote an atmosphere of compliance." While UALR is committed to investigating and taking swift and appropriate action, all of the individuals involved are entitled to due process. For that reason, a public statement by UALR of the nature you suggest would be inappropriate at this time.

As I previously advised, UALR has already notified the Sun Belt Conference and the NCAA of your concerns and of the ongoing investigation. UALR remains strongly committed to working collaboratively with both of these organizations.
